A FORGIVING SPIRIT.

Dr. Talmage Placates the World's Revenges.

He Recommends More of the Saccharine and Less of the Sour in Human Dispositions-Forgiveness Before Sundows.

[Copyright, 1899, by Louis Klopsch.] Washington, Dec. 10.

In this discourse Dr. Talmage placates the world's revenges and recommends more of the saccharine and less of the sour in human dispositions; text. Ephesians, 4:26: "Let not the sun go down upon your wrath."

What a pillow, embroidered of all colors, bath the dying day! The eradle of clouds from which the sun rises is beautiful enough, but it is surpassed by the many colored mausoleum in which at evening it is buried.

Sunset among the mountains! It almost takes one's breath away to recall the scene. The long shadows stretching over the plain make the glory of the departing light on the tiptop crags and struck aslant through the foliage the more conspicuous. Saffron and gold, purple and crimson commingled. All the castles of cloud in conflagration. Burning Moscows on the sky. Hanging gardens of roses at their deepest blush. Banners of vapor, red as if from carnage, in the battle of the elements. The hunter among the Adirondacks and the Swiss villager among the Alps know what is a sunset among the mountains. After a storm at sea the rolling grandeur into which the sun goes down to bathe at nightfall is something to make weird and splendid dreams out of for a lifetime. Alexander Smith in his poem compares the sunset to "the barren beach of hell," but this wonderful spectacle of nature makes me think of the burnished wall of Heaven. Paul in his prison, writing my text, remembers some of the gorgeous sunsets among the mountains of Asia Minor and how he had often seen the towers of Damascus blaze at the close of the oriental days, and he flashes out that memory in the text when he says: "Let not the sun go down upon your wrath." Sublime, all suggestive duty for people then and people now! Forgiveness before sundown! He who never feels the throb of indignation is imbecile. He who can walk among the injustices of the world inflicted upon himself and others without flush of cheek, or flash of eye, or agitation of nature, is either in sympathy with wrong or semi-idiotic. When Ananias, the high priest, ordered the constables of the courtroom to smite Paul on the mouth, Paul fired up and said: "God shall smite thee, thou whited wall!" In the sentence before my text Paul commands the Ephesians: "Be ye angry and sin not." It all depends on what you are mad at and how long the feeling lasts whether anger is right or wrong. Life is full of exasperations. Saul after David, Succoth after Gideon, Korah after Moses, the Pasquins after Augustus, the Pharisees after Christ, and everyone has had his pursuers, and we are swindled or belied or misrepresented or persecuted or in some way wronged, and the danger is that healthful indignation shall become baleful spite and that our feelings settle down into a prolonged outpouring of temper displeasing to God and ruinous to ourselves, and hence the important injunction of the text: "Let not the sun go down upon your

Why that limitation to one's anger? Why that period of flaming vapor set to punctuate a flaming disposition? What has the sunset to do with one's resentful emotions? Was it a haphazard sentiment written by Paul without special significance? No. no; I think of five reasons why we should not let the sun set before our temper.

wrath,"

First, because 12 hours is long enough to be cross about any wrong inflicted upon us. Nothing is so exhausting to physical health or mental faculty as a protracted indulgence of ill humor. It racks the nervous system. It hurts the digestion. It heats the blood in brain and heart until the whole body is first overheated and then depressed. Besides that, it sours the disposition, turns one aside from his legitimate work, expends energies that ought to be better employed and does us more harm than it does our antagonist. Paul gives us a good, wide allowance of time for legitimate denunciation, from six o'clock to six o'clock, but says: "Stop there!" Watch the descending orb of day, and when it reaches the horizon take a reef in your disposition. Unloose your collar and cool off. Change the subject to something delightfully pleasant. Unroll your tight fist and shake hands with some one. Bank up the fires at the curfew bell. Drive the growling dog of enmity back to its kennel. The hours of this morning will pass by, and the afternoon will arrive, and the sun will begin to set, and, I beg you, on its brazing hearth throw all your feuds, invectives and satires.

Other things being equal, the man who preserves good temper will come out ahead. An old writer says that the celebrated John Henderson, of Bristol. England, was at a dining party where political excitement ran high and the debate got angry, and while Henderson was speaking his opponent, unable to

liberately wiped the liquid from his; hating this one and hating that one and face and said: "This, sir, is a digression. Now, if you please, for the main argument." While worldly philosophy selves needing forgiveness for 10,000 could help but very few of such equipoise of spirit, the grace of God could help any man to such a triumph. "Impossible," you say. "I would have knocked the man down." But I have ome to believe that nothing is imposible if God help.

Aye, you will not postpone till sunown forgiveness of enemies if you can realize that their behavior toward you may be put in the catalogue of the "all things" that "work together for good to those that love God." I have had multitudes of friends, but I have found in my own experience that God has so arranged it that the greatest opportunities of usefulness that have been opened before the were opened by enemies. So you may harness your antagonists to your best interests and compel them to draw you on to better work and higher character. Suppose, instead of waiting until 32 minutes after four this evening, when the sun will set, you transact this glorious work of forgiveness at meridian.

Again, we ought not to let the sun go down on our wrath, because we will sleep better if we are at peace with everybody. Insomnia is getting to be one of the most prevalent of disorders. How few people retire at ten o'clock at night and sleep clear through to six in the morning! To relieve this disorder all narcotics and sedatives and morphine and choral and bromide of potassium and cocaine and intoxicants are used, but nothing is more important than a quiet spirit if we would win somnolence. How is a man going to sleep when he is in mind pursuing an enemy? With what nervous twitch he will start out of a dream! That new plan of cornering his foe will keep him wide awake while the clock strikes 11, 12, 1, 2. I give you an unfailing prescription for wakefulness: Spend the evening hours rehearsing your wrongs and the best way of avenging them. Hold a convention of friends on this subject in your parlor or office at eight or nine o'clock. Close the evening by writing a bitter letter expressing your sentiments. Take from the desk or pigeonhole the papers in the case to refresh your mind with your enemy's meanness. Then lie down and wait for the coming of the day, and it will come before sleep comes, or your sleep will be worried quiescence and, if you take the precaution to lie flat on your back, a

frightful nightmare. Why not put a bound to your animosty? Why let your foes come into the sanctities of your dormitory? Why let those slanderers who have already torn your reputation to pieces or injured your business bend over your midnight pillow and drive from you one of the greatest blessings that God can offersweet, refreshing, all invigorating sleep? Why not fence out your enemies by the golden bars of the sunset? Why not stand behind the barricade of evening cloud and say to them: "Thus far and no farther." Many a man and many a woman is having the health of body as well as the health of soul eaten away by the malevolent spirit. I have in time of religious awakening had persons night after night come into the inquiry room and get no peace of soul. After awhile I have bluntly asked them: "Is there not some one against whom you have a hatred you are not willing to give up?" After a little confusion, they have slightly whispered: "Yes." Then I have said: "You will never find peace with God as long as you retain

that virulence." Again, we ought not to allow the sun to set before forgiveness takes place, because we might not live to see another day. And what if we should be ushered into the presence of our Maker with a grudge upon our soul? The majority of people depart this life in the night. Between 11 o'clock p. m. and three o'clock a. m. there is something in the atmosphere which relaxes the grip which the body has on the soul, and most people enter the next world through the shadows of this world. Perhaps God may have arranged it that way so as to make the contrast the more glorious. I have seen sunshiny days in this world that must have been almost like the radiance of Heaven. But as most people leave the earth between sundown and sunrise they quit this world at its darkest, and Heaven, always bright, will be the brighter for that contrast. Out of darkness into ir-

Shall we then leap over the roseate bank of sunset into the favorite hunting ground of disease and death, carrying our animosities with us? Who would want to confront his God, against whom we have all done meaner things than anybody has ever done against us, carrying old grudges? How can we expect His forgiveness for the greater when we are not willing to forgive others for the less? Napoleon was encouraged to undertake the crossing of the Alps because Charlemagne had previously crossed them. And all this rugged path of forgiveness bears the bleeding footsteps of Him who conquered through suffering, and we ought to be willing to follow. On the night of our departure from this life into the next our one plea will have to be for mercy, and it will have to be offered in the presence of Him who has said: "If you forgive not men their trespasses, neither will your Heavenly Father for-

wishing that one a damage and wishing some one else a calamity, and we ourobliquities of heart and life. When our last hour comes, we want it to find us all right.

And il will be a grand thing if, when our last moment comes, we are found in right position toward God, on guard and unaffrighted by the descending ashes from the mountains of death. I do not suppose that I am any more of a coward than most people, but I declare to you that I would not dare to sleep tonight if there were any being in all the earth with whom I would not gladly

> shake hands, lest during the night hours my spirit dismissed to other realms, I should, because of my unforgiving spirit, be denied Divine forgiveness.

"But," says one woman, "there is a horrid creature that has so injuied me that rather than make up with her I would die first." Well, sister, you may take your choice, for one or the other it will be-your complete pardon of her or God's eternal banishment of you. "But," says some man, "that fellow who cheated me out of those goods or damaged my business credit or started that lie about me in the newspapers by his perfidy broke up my domestic hap-piness, forgive him I cannot, forgive him I will not." Well, brother, take your choice. You will never be at peace with God till you are at peace with man. Feeling as you now do, you would not get so near the harbor of Heaven as to see the lightship. Better leave that man with the God who said: "Vengeance is mine, I will repay." You may say: "I will make him sweat for that yet; I will make him squirm; I mean to pursue him to the death," but you are damaging yourself more than you damage him, and you are making Heaven for your soul an impossibility. If he will not be reconciled to you, be reconciled to him. In five or six hours it will be sundown. The dahlias will bloom against the western sky. Somewhere between this and that take a shovel and bury the old quarrel at least six feet your wrath."

About Continuous Milking.

A writer in the Jersey Bulletin says he or she has but one cow in a berd of 20 that has ever gone dry more than a month at a time before calving. That cow was brought into the berd and was dry three months before she dropped another calf. With her next calf she went dry about six weeks and does so now. Most of the herd have never been dry at all since they had the first calf. Although the milk is not used in the dairy for a month before they calve, they are milked regularly, and no difference can be seen between the well-fed cow that does not go dry at all and other cows that go dry one or two months, so far as health, vigor or lasting qualities go. It is largely a matter of habit, and if a heifer is allowed to go dry after her first calf she is more apt to go dry a little longer the next time.

Skillful pruning is absolutely necessary for securing continued crops of good fruit of any kind.

Moravia Road Contract.

"The fact that the Syracuse, Skaneateles & Moravia Railway company has been awarded a contract for the construction of its road is claimed by the concern to be sufficient evidence that the road will be built and therefore during this week application will be made to the state railroad commission for reopening the hearing on the application of the company," says the Syracuse Post-Standard.

"The contract referred to calls for a mile of elevated track on a steel structure, through the city from near Bolvay to Geddes street. This structure is designed for crossing the track of the Auburn road and the Rapid Transit company."

FOR THE RECRUITS.

THE United States coastwise transport Butuan, two days out from Manila, arrived at Iloilo, on the island of Panay, at six p. m. October 3, 1899. The party of six recruits for the 'Steenth infantry, of which was a member, was met at the dock by a corporal and escorted in heavy marching order to an outpost in the town of Jara, about five miles from Iloilo. We found company D of our regiment comfortably quartered in two big hotels that had been abandoned by the Spanish when the town was taken by the Americans. We arrived at about eight p. m., after a tramp through mud half way to our knees, and were promptly assigned to quarters. The first man I met in the squad room was "Smithie," an old bunkie with whom I had been on recruiting duty back in the states. He knew me at once, but it was a full minute before I could discover his identity through the mask of tan

"How!" he shouted, banging me between the shoulder blades with a sledge hammer fist and bugging me until my ribs cracked. "How! When did you vamoose the Sammies? Domi poketa an du Yank tobac?"

"Hey?" said 1, in bewilderment. "Bah!" said he, motioning me to unbarness and sit on his bamboo bunk, "I forgot. You no savey the pidg. I asked when you left the states, and if you had any Yankee tobacco. Savey?"

I gave the desired information and produced a bag of tobacco. Then I asked: "What is, savey the pidg?"

"That's understand Kakiack English-Filipino English," he explained. "Savey? You'll soon learn to shoot it. Have you chow-chowed yet? What? Why, hang it, hombre. I asked if you had chewed yet. Eaten. Chow-chew-savey? No? Want a poco tempo. I'll get you a carabao sandwich and a shell of tuba.

"Look here, Smithie," said I, in desperation. "You'll have to talk English or hire an interpretetr. What you are talking about is more than I know."

Parous Plasters.

The adhesive mass used on the face of porous plasters varies in composition, though the following may be taken as representing the general formula followed in the better class of plasters: Rubber, two parts; Burgundy pitch, one part, and gum olibanum, one part. This mass is varied somewhat for different kinds of plasters, and there is no doubt that cheaper substitutes for the olibanum are used. Powdered orris root also is frequently present in the mass as a diluent. To work this mass successfully heavy and expensive machinery is required, and considerable skill is necessary to produce plasters which remain permanently flexible and adhesive. For these reasons the manufacture of porous plasters has practically passed out of the hands of the retail druggist into the hands of those who make them on a large scale .-American Druggist.

A Crest of Cloth.

One of the ornithologists attached to the Smithsonian institution was collecting specimens of the birds of southwestern Mexico not long ago, when he saw a cow bird which seemed to him to possess a white crest. Now, properly, the cow bird is altogether black, and the top of his head is as smooth as the poll of a young dry goods clerk. Evivestigation, and a gunshot brought the bird to the ground. Then was found a more unexpected marvel than was anticipated. The "snow-white crest" proved to be a piece of white cloth that had been stitched into the bird's scalp and trimmed to represent a cock's comb. "It had doubtless been done when the bird was very young," says the observer, "by some of the natives, and the wounds of the operation were entirely healed."-Lippincott's.

Chesper Than Star Routes and More Effective Than Country Post Office Methods-The Work to Be Extended.

[Special Washington Letter.] JIRST Assistant Postmaster General Perry S. Heath was for about 15 years the Washington correspondent of some of the best daily newspapers in this country. He was a successful newsgatherer, a hard worker, and always a genial gentleman. Every newspaper man in the national capital was his friend, and today they cannot write of his work in public office without using words of commendation because of their high esteem. However, his work in high office well warrants a fair degree of praise, for it has been painstaking and faithful if not brilliant.

The office of the first assistant postmaster general is wholly devoted to business affairs, and is practically relieved of all political complications. This condition was brought about by Postmaster General Wanamaker, with the cooperation of the congress, in inadequate to the task imposed. 1890. Postmaster General Wanamaker is a business man, and while he occupied a position in the cabinet he endeavored, with some degree of success, to apply business methods of administration to the post office depart-

For many years before the beginning of the Harrison administration there had always been three assistant postmasters general, and the first assistant postmaster general had charge of the appointments of all fourth class pastmasters, the number being upwards of 50,000. This number has now increased to upwards of 65,000. Excessive partisan use of the office was first made in 1885 and 1886 by First Assistant Postmaster General Stevenson, who removed all republican fourth class postmasters as rapidly as possible, sometimes reaching the number of 200 per day. He was followed by First Assistant Postmaster General Clarkson, who outdid the record of Stevenson; for he sometimes removed as many as 250 democratic postmasters in a single day. To make a clean partisan record these democratic and republican first assistant postmasters general were obliged

to work thus diligently, in order to make changes in all of the fourth class postmasterships during their terms of four years each; and they worked their clerical force sometimes by night as well as by day so as to accomplish the object.

Postmaster General Wanamaker induced the congress to authorize an additional assistant, designated as fourth assistant postmaster general, and he was charged with the duty of appointing all fourth class postmasters. By this arrangement the first assistant postmaster general's office was relieved of the political drudgery, and was placed opon a business basis. During the second Cleveland administration, however, the rule was adopted that fourth class postmasters shall each serve four years, and the official ax ceased to be wielded without cause and solely for partisan purposes. This marked a commendable era in genuine civil service reform.

First Assistant Postmaster General Heath, finding his office upon a business basis, began his work with the purpose of extending existing postal facilities upon lines already laid down; and by bringing to the postal service some new and practical ideas of his

In supervising the work of this important office he is obliged to direct the salaries and allowances of postmasters, their assistants and clerks, and all expenditures for rent, fuel, lights and incidentals. This alone. covering almost 70,000 post offices, including the presidential offices, is sufficient to demand a great deal of time and consideration. But he has also to supervise the free delivery division, covering all letter carriers and their work; the purchase of supplies for all post offices, including stationery. blanks, books, wrapping paper, twine, letter balances and everything the post offices are entitled to receive: also the money order division, which alone is a great and far-ramifying ma-

fice, with its army of clerks. brief statement of the responsibilities devolving upon the first assistant postmaster general will readily assure the for the duties thus defined must be possessed of business abilities of a more than ordinary measure, the genius of labor.

Mr. Heath has not only managed to fulfill the functions of his great office in every particular, but he has also taken up a special work which is of in-

terest to all of our people, and that is the subject of rural free delivery. To this he has paid particular attention. and he is now endeavoring to interest the senators and representatives in the dissemination of mail matter to the ceople of the farms and villages, so that they may receive facilities similar to those extended to the dwellers in cities who have their mail brought to their homes and business places by letter

When he came into office Mr. Heath found that the rural free delivery had been partially established, but that preceding postmasters general had considered it impracticable, and that they had experimented with it without heart in the matter. Only \$50,000 had been appropriated for experimental purposes for an entire fiscal year-a sum wholly

Looking carefully into the matter and receiving petitions from rural citizens

and grange organizations throughout the country, Mr. Heath concluded that the system should be extended, and he secured an appropriation of \$150,000 for the first year of his term and another appropriation of \$300,000 for the preshis disposal he extended the work, so that he now says: "It is no longer in a practical standpoint. With the cooperation of congress this rural free delivery service should be extended to the entire rural population."

The annual report of the first assistant postmaster general shows that rural free delivery has been established in all of the states of the republic, excepting Idaho, Montana, Wyoming and Mississippi; and those exceptions have been made because of the conditions of the roads and the sparsely settled condition of so many thousands of acres of the public domain. There are 383 dis- ITHACA tributing stations for the rural free delivery service, and a population of 180 .-000 receives the benefit of these facili-

People in cities who reside next door to the post offices have their mail earried to them. They do not have to walk a step to get their mail, but one of Uncle Sam's uniformed letter carriers brings their mail to them. Farmers have been obliged to walk or drive a mile, or five miles, or ten miles, to town to ascertain if there is or is not a letter in the post office awaiting their call. Mr. Heath has established mail boxes along the routes of good roads, where farmers may deposit their letters, and the rural free delivery carriers come there and take up the mail to be forwarded, and at convenient points they also deliver mail to the farmers. It is much easier to send one of the boys or girls down to the cross roads for the mail, to meet the free delivery wagon, than it is to hitch up and drive to town, thereby losing much time from necessary farm work, taking both horse and man from their regular farm duties.

The rural free delivery routes decrease the incomes of fourth-class postmasters, and star routes are dispensed with; so that this service has been established in spite of the hostility of Union Bl'k-Moravia, N. Y. many postmasters and of all star route contractors. All of these people-have more or less influence with senators and representatives in congress, but the first assistant postmaster general says that the plain people have more influence, and they are sustaining him in the great work. He says: "I believe it is possible to extend rural free delivery to millions of citizens without addition- of the winter coal. Our price is a al expense to the post office department, and consequently without increased appropriations by congress."

This practical and dettermined official has gone much farther than he originaily anticipated. But, seeing the success of rural free delivery, he has caused to be made a traveling post office, a complette outfit on wheels. This experiment has been made in Carroll county, Md., where a wagon eight feet long travels over good roads, delivering and receiving mail, canceling, delivering, giving receipts for registered letters and for money order applications
