REVOLUTIONARY WAR RECORD OF LYON FAMILY

- 1. Caleb Lyon Sr. (T-52) served as private in Colonel Thaddeus Crane's Regiment Westchester Militia in 1782. He signed a petition against allowing Torries who had served in the British Army to return as citizens of Stamford and Greenwich (Connecticut).
- 2. Caleb Lyon Jr. (T-163) Armourer in the 9th Regiment Connecticut Militia under Captain Matthew Mead, August 3rd through September 8, 1776. Also October 1776 as private in Captain Laurence's Company in Colonel Thaddeus Crane's Regiment. Also served in the 9th Connecticut. Militia under Captain Matthew Mead, giving him Land Bounty Rights.
- 3. Daniel Lyon of Fairfield (T-164) Sergeant in 9th Regiment Connecticut Militia under Captain Abraham Mead November 1, 1776 to January 11, 1777.
- 4. Amos Lyon (T-166) Private in Connecticut Militia under Captain Abraham Mead, August 13 through September 7, 1776. Also Corporal in 9th Regiment Connecticut Militia under Captain Abraham Mead "At the Saw Pitts," November 1, 1776 through January 11, 1777.
- 5. Noah Lyon (T-167) of Greenwich was private in Captain Abraham Mead's Company, called out at the Lexington Alarm, April 1775. Also in the 5th Regiment Connecticut Line under Captain Thomas Hobby, May 10 through December 8, 1775. He later served in the Connecticut Militia under Captain Abraham Mead November 1, 1776 through January 11, 1777.
- Job Lyon (T-168) Private in Connecticut Militia under Captain Abraham Mead, August 13 through September 25, 1776. Drew pension in Fairfield County (Connecticut) 1832.

Thaddeus Mead, father in law of Noah Lyon, was a private in the Connecticut Line and New York forces. He enlisted under Captain Samuel Haight in 3rd Regiment Westchester Militia giving him Land Bounty Rights.

Noah Lyon's Pension Record - Washington #W16640 was about 1758. While residing in Greenwich, Connecticut, he enlisted May 10, 1773 and served as private in Captain Thomas Hobby's Company in Colonel David Waterbury's Connecticut Regiment. He was in other services but no details were given. Noah married on March 29, 1781 in South Salem, Westchester County, New York to Mary Mead, by Reverend Solomon Mead a Presbyterian Minister. Noah died in 1820 and his widow Mary died August 21, 1841. Two children survived her and were allowed the pension due her. Thaddeus Lyon of Genoa, Cayuga County, New York and Ruth Curtis of Huron County, Ohio, both were over 21 years of age.

After the Battle of Lexington, April 1775, volunteered for the march to Boston with Captain Abraham Mead's Company of Horse Neck, 9th Regiment.

Certificate issued in the sum of ξ ,9 s8 d 1/4 issued on account of his services under Captain Samuel Laurence in the 4th Regiment of Westchester County Militia.

The Lyon home near Greenwich was burned by the British, and they moved to Westchester County until after the war. So you see that <u>Caleb Lyon Sr</u>. and his five sons were all soldiers in the Revolutionary War.
